WGEA reporting assumes that our Group can dictate to partially owned businesses how they implement gender equality objectives and effect change. The holding company, AUB Group Limited, cannot do this - the organisation is set up to allow the businesses it partially owns to run themselves. AUB Group Limited purchases shares (on average ~65%) in insurance intermediaries across Australia. The proprietors of the businesses are responsible for the dayto-day management of the business. Each business is a separate unit, and typically there is no direct career progression between the individual businesses or to the Holding Company. Factors Creating Distortions in Reporting 1. AUB only reports on >50% owned businesses. In the questionnaire section if the answer is "no" for one business, then the answer is "no" across the board even if all other businesses were a "yes". 2. No centralised functions – AUB does not have human resources or payroll functions covering the entire Group. Workplace profile information and gender policies are managed individually at each of the businesses. 3. No monitoring of gender equality policies – AUB's network of businesses is not required to adopt template policies, and AUB cannot monitor all the businesses as it does not have this power. The non AUB shareholders drive the businesses and their employee and workplace strategies, including gender equality. Any gender and human resources policies and strategies made at the AUB Group Limited level may not always be adopted at the Partner level. 4. Gender Composition of subsidiary Boards - The gender composition of CEO roles and Board Member positions in each business is determined by shareholding. The setting of any gender composition targets is ineffective.
